Day by Day Itinerary

November 3 Day 1 Depart USA: Your pilgrimage begins today as you depart on your flight to Barcelona.

November 4 Day 2: Arrive Barcelona: Upon arrival in Barcelona, we are greeted by our Holy Land Travel Center Representative and transfer into the capital of Catalonia and transfer to our hotel for dinner and overnight.

Overnight: Barcelona (Dinner)

November 5 Day 3: Barcelona: This morning we will visit La Sagrada Familia Basilica designed by architect Antoni Gaudi. We enjoy a full guided tour of the Basilica before we celebrate Mass. We will then continue to Park Guell before we return to our hotel for dinner and overnight.

Overnight: Barcelona (Breakfast, Dinner)

November 6 Day 4: Barcelona: Today we tour Sacred Heart Minor Basilica located on top of Mount Tibidabo before celebrating Mass. We then have the afternoon free in Las Ramblas.

Overnight: Barcelona (Breakfast, Dinner)

November 7 Day 5: Montserrat: This morning we will travel outside of Barcelona for a full day visit to the Sanctuary of Our Lady of Montserrat, the spiritual heart of Catalonia and home to a Benedictine monastery. For 700 years this Marian Shrine has attracted thousands of pilgrims from around the world. St. Ignatius of Loyola prayed in front of this same image of Our Lady of Monserrate around 1522.

Overnight: Montserrat (Breakfast, Dinner)

November 8 Day 6 Lourdes: This morning we will travel to Lourdes stopping for lunch along the way. Upon arrival we will check into our hotel. Our hotel is close enough that you will be able to walk to the Lourdes Grotto at night if you so choose.

Overnight: Lourdes (Breakfast, Dinner)

November 9 Day 7 Lourdes: Grotto of Massabielle, Basilica of St Pius X: This day we start with Mass at the Grotto of Massabielle, where Our Lady appeared to Bernadette in 1858; followed by our guided tour of Lourdes. The sanctuary of the Basilica of St. Pius X, the world's largest underground church. Since the pandemic, full immersion at the baths is no longer allowed, but you can participate in a water blessing if you choose.

Overnight Lourdes (Breakfast, Dinner)

November 10 Day 8: Lourdes to Zaragoza: This morning we depart Lourdes and traverse the Pyrenees southward entering northern Spain. We travel eastward to Zaragoza, the capital of Aragon. On arrival, we tour the city which was founded by the Romans. We break for lunch on our own before continuing our tour. This city was also the birthplace of Goya, whose works grace many of the sites we visit. The Basilica de Nuestra Senora del Pilar commemorates the apparitions of Our Lady to St. James the Apostle in the year 40AD. If possible, we celebrate Mass there. Dinner and overnight at our hotel.

Overnight: Zaragoza (B, D)

November 11 Day 9: Zaragoza, Loyola & Burgos: Today we depart Zaragoza on our way to Burgos. En route, we stop at the 17th Century Sanctuary of Loyola. This architectural complex is formed by the tower-house of the Loyola family, which was the birthplace of San Ignacio de Loyola, founder of the Jesuit Religious Order. We will celebrate Mass in the chapel of the Loyola Family home. Once we arrive in Burgos we will check in to our hotel for dinner and overnight.

Overnight: Burgos (B, D)

November 12 Day 10 Burgos, Santiago De Compostela: Today we visit the Cathedral of Saint Mary of Burgos, located in the historic city of Burgos, Spain. This Cathedral is a UNESCO World Heritage site and a symbol of Spain's cultural and religious heritage, and dedication to Our Lady. We will have time for lunch on our own; then head to Santiago de Compostela for dinner and overnight.

Overnight: Santiago de Compostela (B, D)

November 13 Day 11 Santiago De Compostela: Santiago De Compostela Cathedral, Crypt of St. James, City Tour: This morning we begin our visit of Santiago de Compostela, one of the most famous shrines in the world, where the tomb of St. James the Apostle (brother of St. John the Apostle) was discovered. As pilgrims, we can climb the stairs behind the high altar to visit the crypt where the relics of St. James are preserved, touch the central pillar (Portico de La Gloria), view the botafumeiro (large censer) and admire the wealth of medieval art inside the Cathedral. We have a free afternoon to enjoy a long lunch or walk around the historic city. Return to our hotel for dinner and overnight in Santiago de Compostela.

Overnight: Santiago de Compostela (Breakfast, Dinner)

November 14 Day 12: Santiago De Compostela / Porto / Fatima: Today we depart Santiago de Compostela and continue to Porto where we visit the Church of St. Francis. After lunch in Porto, we drive to Fatima for dinner and overnight. Our hotel will be close enough to the Chapel of Apparitions that you can walk there after dinner if so choose.

Overnight Fatima (B, D)

November 15 Day 13: Fatima: Rosary & Candlelight Procession: This morning we visit Fatima, where in 1917 Our Blessed Mother visited three shepherd children, Lucia Santos and her cousins Jacinta and Francisco Marto. We will pray at the tombs of now Blessed Lucia, Saint Jacinta, and Saint Francisco. We participate in the Rosary and Candlelight Procession during the evening.

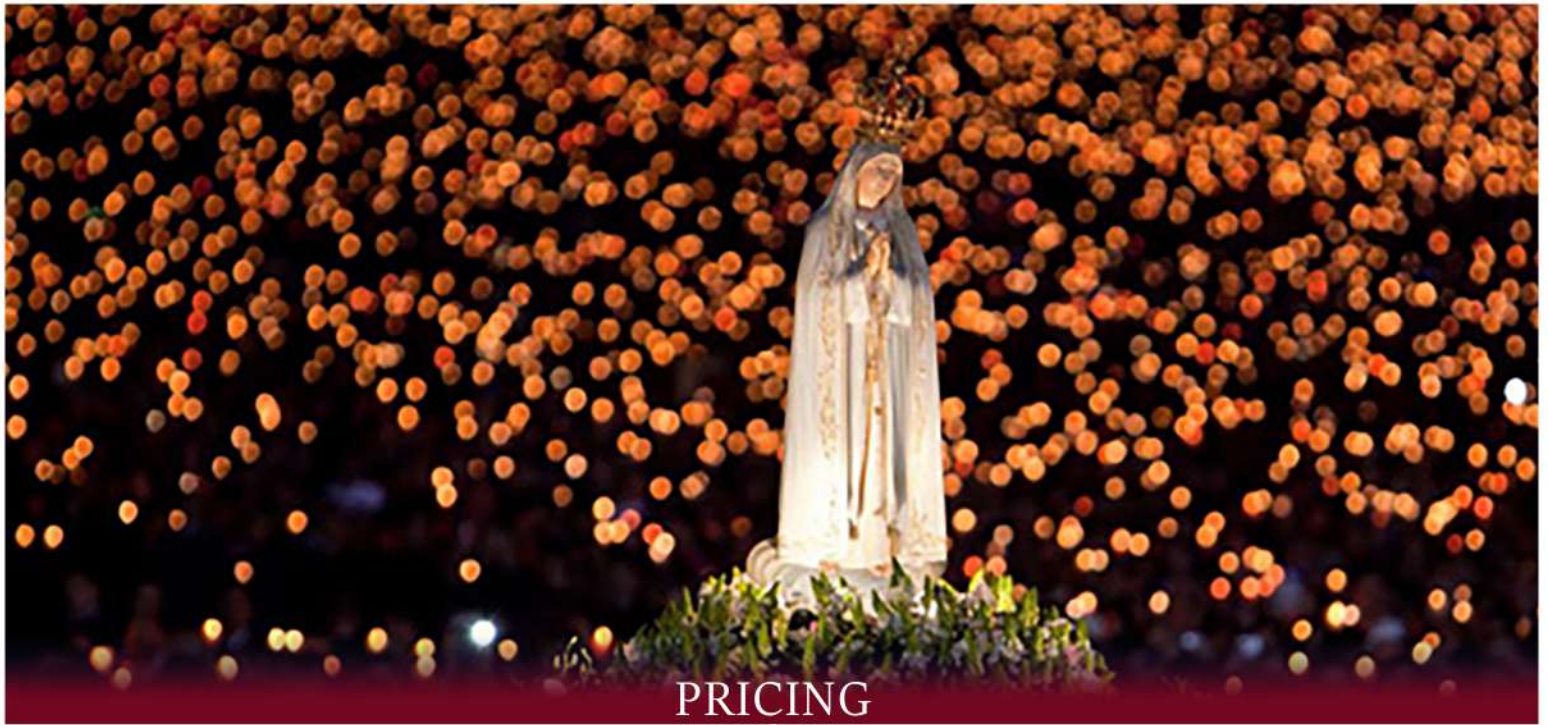
Overnight: Fatima (Breakfast, Dinner)

The tours are professionally organized to ensure that pilgrims receive the highest quality in travel and lodging. But we pride ourselves most on offering a personalized experience. From the first day you are treated like family, welcomed into the local Christian homes, offered stories of faith by residents, and unfettered access to holy sites.

Terms & Conditions

By making any payments (cash, credit card or otherwise) towards any tour constitutes your unconditional acceptance of all the terms and conditions stated in this brochure. Holy Land Travel Center shall be referred to as HLTC within this document.

DOCUMENTS: US citizens require a valid passport. Other nationalities please inquire with the appropriate embassies.

REGISTRATION AND DEPOSIT: Deposit of \$500 per person is required upon registration along with a signed copy of the registration form. Registrations are processed in the order received by HLTC. Final payment is due 45 days prior to departure. Late payments are subject to a \$50 late fee per week past the due date. HLTC reserves the right to cancel reservations whose payments are 30 days late and to apply applicable cancellation/penalties indicated below. No registrations can be made over the telephone.

INDIVIDUAL CANCELLATION POLICY & REFUNDS: In the event of your, the registrant's, cancellation of participation in the tour, regardless of the reason, HLTC will provide refunds for services not rendered, deducting applicable cancellation fees per person, upon receipt of your written cancellation notice. This notice must be submitted either via the email address used for registration or through US mail.

1. For cancellations made from the time of registration up to 120 days prior to the tour's departure date, a minimum cancellation fee of \$500 applies, which is nonrefundable.
2. Cancellations made between 119 to 60 days prior to the departure date will incur a cancellation fee of \$500 plus 20% of the total price, both of which are nonrefundable.
3. For cancellations made between 59 days to 31 days before the departure date, the cancellation fee will amount to \$500 plus 50% of the total price, and both components are nonrefundable.
4. Cancellations made from 30 days prior to the departure date onwards will not be eligible for any refund, rendering the booking completely nonrefundable.

PAYMENT: The advertised price reflects the discounted rate applicable to cash or check payments. If payment is made via credit card, a processing fee will be applied.

NONREFUNDABLE AGREEMENT: The traveler acknowledges and agrees that the term "nonrefundable," as used in any quotations, bookings, or invoices, signifies that the booking cannot be refunded under any circumstances, including but not limited to reasons such as pandemics, wars, force majeure events, or other unforeseeable occurrences. In such instances, the cancellation fees outlined above shall apply. By accepting the nonrefundable terms, the traveler expressly waives their right to initiate legal action or pursue credit card disputes, including "chargebacks," against the travel advisor or its affiliated partners for any resulting penalties, fees, or purported damages arising from nonrefundable deposits/payments or any other transaction. Furthermore, the traveler is obligated to reimburse the travel agent for any financial penalties incurred due to credit card chargebacks.

TRAVEL PROTECTION: Travel insurance is recommended to help protect you and your trip investment against the unexpected. For your convenience, we offer travel protection. If you do not wish to purchase now, the plan can be purchased any time before submitting your final payment. Coverage takes effect once payment is received. If you choose to purchase outside of the time sensitive period outlined in the plan, you will not be eligible for time sensitive benefits. All plan premiums are non-refundable. MEDICAL CONDITION: We endeavor to provide the highest level of service to all our passengers. Participants who require special assistance must be accompanied by a qualified helper who assumes total responsibility for the participants' well-being. This pilgrimage demands a lot of walking and can be strenuous. HLTC is not responsible for any medical conditions that occur prior to, during, or after the tour.

LAND TRANSPORTATION AND TRANSFERS: Transportation throughout the tour will primarily be conducted via private deluxe motor coach, ensuring comfort and convenience for participants. However, in the event that group minimums are not met, alternative arrangements may be made, necessitating the use of a smaller vehicle for transportation.

ACCOMMODATIONS: Tour prices are per person, based on two persons sharing double or twin-bedded rooms with a private bathroom with tub or shower. In the event that one does not sign up with a roommate and is not able to be paired with another traveler, there will be a single supplement charge to the account. Single rooms subject to availability and an additional cost indicated on the brochure. Accommodations are subject to change due to upgrade, size of group, etc.

MOBILE APP: Final pilgrimage details will be available through an app before departure. Please be aware that the information on the app is regularly updated and subject to change. HLTC (Holy Land Travel Company) holds no liability for errors or discrepancies in the app's content.

MEALS: Meals in accordance with the itinerary. All beverages are extra.

TIPPING: Unless it is specified in the tour brochure, the price of the tour does not include tips and gratuities. Tipping is recommended to the tour guide and motor coach driver approximately \$6 and \$4 per person, respectively, per day to each. Hotel tips are approximately \$2 per day per person. Tips may be pre-collected before the pilgrimage for your convenience.

AIRLINE TICKETS AND ITINERARY LENGTH: Air transportation to/from your destination will be economy class aboard carriers utilizing non-refundable, non-amenable tickets. Preliminary international flight schedules are available 60 days prior to departure and may change before they are finalized. Therefore, if you book the domestic flight on your own, you will be responsible for changing your domestic flights and incurring any change fees that would be generated by this adjustment. We are not responsible for changes and delays in airline schedules and do not reimburse passengers for expenses resulting from such occurrences. Travelers making their own flight arrangements should not purchase non-refundable, non-changeable tickets. We cannot guarantee the most direct routing to your final destination. If flight schedules change, we reserve the right to lengthen or shorten the itinerary accordingly, and if changes or flight schedules necessitate extra overnights, you will be charged at normal hotel rates. Land Only packages do not include airport-hotel transfers.

ALTERNATE AIRPORT ARRANGEMENTS: Should you desire departure from a different airport than the group, we will seek a price estimate for an alternative flight. If the provided flight options are not satisfactory to you, we will convert your booking to a Land Only Request, enabling you to arrange flights and transfers independently. The Land Only price is detailed in the brochure.

SEAT ASSIGNMENT: THERE IS NO ADVANCE SEAT SELECTION FOR TOUR DEPARTURES. HLTC cannot guarantee specific seats, which are at the discretion of the airline and are pending availability. When HLTC disperses travel packages, you will receive your record locator. You can use this locator to do online seating arrangements, if permitted by the airline, any additional costs for seat selection are your responsibility. If your airline ticket is canceled for any reason, you must directly contact the airline to request a refund for your seat selection. The refund will be processed to your original form of payment, subject to the airline's terms and conditions.*

BAGGAGE: Transatlantic and transpacific flights to and from the USA allow the passenger to bring one (1) checked bag, which may have a maximum weight of 50 lbs., and maximum combined dimensions of 62 inches. Also, one (1) "carry-on" with maximum dimensions of 8"x12"x20" is permitted. Luggage on domestic flights including Mexico & Canada will cost extra. Luggage is the passenger's responsibility and that of the airlines. For lost luggage, the passenger is responsible for notifying the airline directly. Check with your carrier regarding carry-on luggage rules and regulations.

PRICING: The prices stated herein are contingent upon prevailing exchange rates and fares at the time of quotation and are predicated upon a minimum number of paying passengers as delineated in the brochure. Consequently, these prices are subject to modification in the event of fluctuations in fares (inclusive of fuel surcharge increases), failure to meet the stipulated minimum passenger count, or alterations in exchange rates. NOT INCLUDED: Passport and Visas, exit taxes, meals not mentioned, beverages with meals, extra beyond standard menu, excess baggage, luggage on domestic flights, telephone calls, fuel surcharges increase.

VISAS: When and if a visa or visa waiver is required, it is the passenger's responsibility to obtain one. PASSPORTS: Passports are required to travel with Holy Land Travel Center. A Passport Card is not useful for International Air Travel. Attempting to use this instead of a Passport Book will result in a denial of boarding by the airlines and entry by the legal authorities.

VISA FOR EUROPE - ETIAS
-Starting in 2025, Americans, Canadians, Australians will need to apply online for travel authorization for Europe.
- This applies to all travelers, and all ages.
- Fee approx. \$9. Per Person
- The program is called ETIAS. Some refer to it as a "visa for Europe". It is not a traditional visa but needs basic details about the traveler and their trip.
